Item 6: Consideration of UPR Reports, GHANA

Oral Statement, Association for the Prevention of Torture

Mr. President,

The Association for the Prevention of Torture (APT) welcomed Ghana's commitment to ratify the Optional Protocol to the United Nations Convention against Torture [and Other Cruel, Inhuman or Degrading Treatment or Punishment] (OPCAT) during the Universal Periodic Review (UPR) last October.<sup>1</sup>

Yet, we recall that Ghana made the same commitment four years ago during its first UPR review when it accepted three recommendations to ratify the OPCAT.<sup>2</sup>

In 2009, the government took initial steps towards ratification by submitting a bill on ratification to the parliament, but since then all forward momentum has stopped.

In 2011, the UN Committee Against Torture recommended that Ghana "accelerate the ratification process, as well as the designation of a national preventive mechanism."

Now, in the second UPR review, seven States have recommended OPCAT ratification and/or the establishment of a national preventive mechanism, as envisioned in the treaty. For its part, Ghana has either accepted those recommendations or indicated that they are in the process of implementation.<sup>4</sup>

APT is interested to learn what measures have been taken to implement these recommendations to date.

We further encourage Ghana to: (1) ratify the OPCAT by the end of the year; and (2) take prompt measures to designate a national preventive mechanism through an open, transparent, and inclusive process.

We hope that the parliamentary and executive authorities will now act upon national and international calls to move ahead with torture prevention in Ghana.
